

PUBLIC NOTICE - The following proposed ordinance of the Borough of Chambersburg will be brought up for enactment within not less than 7 days or more than 60 days after the date of this notice. A public meeting is scheduled for Monday, November 18, 2024 at 7:00 PM in Council Chambers, 100 South Second Street, Chambersburg, PA to consider enactment of the following:

PROPOSED ADOPTION OF AN ORDINANCE TO AMEND CHAPTER 286, VEHICLES AND TRAFFIC, OF THE CODE OF THE BOROUGH OF CHAMBERSBURG BY AMENDING THE FOLLOWING: Amend Article III, Parking Regulations, Section 286.25, Parking Prohibited at all Times in Certain Locations, 286.14, Stop Intersections established; and 286.14, Stop Intersections established.

SECTION NO. 1. The following shall be **DELETED** from Article III, Parking Regulations, Section 286-25, Parking Prohibited at all Times in Certain Locations:

SECTION NO. 2. The following shall be **ADDED TO** Article III, Parking Regulations, Section 286.25, Parking Prohibited at all times in Certain Locations:

SECTION NO. 5. Pursuant to Article IV, Parking Regulations, Section 286.39, Parking meter zones established, of the code of the Borough of Chambersburg, Council herein ratifies the addition of nine metered on-street parking spaces on the South side of North main Street

located within the Main Street parking meter zone, as directed by the Borough Manager and recommended by the Parking, Traffic and Street Light Committee.

SECTION NO. 6. This ordinance shall become effective upon adoption.
