AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF CHAMBERSBURG BY REVISING CHAPTER 300, SECTION 300-35 RELATING TO PERMITTED USES.

BE IT ORAINED BY THE BOROUGH OF CHAMBERSBURG AND IT IS HEREBY ORDAINED BY AUTHORITY OF THE SAME AS FOLLOWS:

Section 1. Legislative Findings. Whereas the Borough has determined it appropriate to expand the uses permitted in the Distributed Commercial-Highway zoning district, the following amendment to the Code of the Borough of Chambersburg is hereby adopted:

Section 2. CHAPTER 300, ARTICLE V, Section 300-35 entitled Uses Permitted is hereby revised to add a new paragraph K. to read as follows:

K. SIC Number 20, Food and Kindred Products, as a use accessory to a permitted restaurant or retail principal use, except:

SIC 2011: Meat Packing Plants

SIC 2013: Sausages and Other Prepared Meat Products

SIC 2015: Poultry Slaughtering and Processing

SIC 2041: Flour and Other Grain Mill Products

SIC 2044: Rice Milling

SIC 2045: Prepared Flour Mixes and Doughs

SIC 2046: Wet Corn Milling

SIC 2047: Dog and Cat Food

SIC 2048: Prepared Feed and Feed Ingredients for Animals and Fowls, Except Dogs and Cats

SIC Number 20: Food and Kindred Products, shall be permitted contingent upon the appropriate permits or licensing from state or federal regulators.

Section 3. SAVING CLAUSE. Nothing in this Ordinance shall be construed to affect any suit or proceedings in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any ordinance hereby revised or otherwise affected by this Ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

Section 4. SEVERABILITY. The provisions of this Ordinance are severable and if any of its sections, clauses or sentences shall held be held illegal, invalid or unconstitutional, such provision shall not affect or impair any remaining sections, clauses or sentences of the same.
