You will need to obtain and maintain a performance and surety bond in the amount of \$10,000.00 (ten thousand dollars) with an acceptable bonding company. A copy of the form is attached.

The Borough of Chambersburg must have a copy of your Bond before you will receive any Electricians License.

ELECTRICIAN'S BOND

KNOW ALL MEN BY THESE PRESENTS, That we _____
_____, as Principal, and

_____ as Surety, are jointly and severally held and firmly bound unto the Mayor and Town Council of the Borough of Chambersburg, a municipal corporation in Franklin County, Pennsylvania, herein called Borough, in the sum of ten thousand (\$10,000.00) dollars, lawful money of the United States, to be paid to the said Borough, its certain attorneys, successors or assigns, to which payment, well and truly to be made and done, we and each of us do hereby bind ourselves, our heirs, executors, administrators, successors or assigns, and every of them.

SEALED with our hands and seals and dated the _____ day of _____, 20_____.

NOW THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That if the above bounded Principal and Surety, their heirs, executors, administrators, successors or assigns, or any of them, shall and do pay all sums of money for which the said _____, Principal, may become liable as a result of the violation in the performance of his work as a Master Electrician under the terms of an Ordinance of the Borough passed by the Town Council on the 27th day of December, 1978, and approved by the Mayor on the 27th day of December, 1978, as amended by the Mayor and Town Council on the 10th day of November, 1993.

This bond shall remain in full force and effect as to the Principal so long as he is the holder of an electrician's license issued by the Borough, and as to the Surety for one year from the date hereof and thereafter until terminated by written notice to the Borough at least then (10) days prior to the end of the year or to the date of termination, whichever is later.
