

NOTICE - SEEKING BIDS

BOROUGH OF CHAMBERSBURG MULTIMODAL INTEGRATION PROJECT

The Borough of Chambersburg is accepting sealed bids online via the PennBid Program (www.PennBid.net) for the "Borough of Chambersburg Multimodal Integration Project."

A complete proposal packet may be obtained online, at no cost, at www.PennBid.net

The Contract involves the competitive solicitation of construction bid for the Borough of Chambersburg Multimodal Integration Project. Bids will be based on a unit price. The Town Council intends to award the Contract to the overall lowest responsible Bidder, as determined by Town Council to be in the best interest of the Borough of Chambersburg.

A Proposal Bond in the amount of ten percent (10%) of the bidders maximum bid price is required to be accompanied with a Bid. A Performance Bond and Payment Bond each in the amount of one hundred percent (100%) of the contract price shall be required from the Successful Bidder. An non-collusion affidavit is required for this Bid. The Contract will be subject to the greater rate of the Pennsylvania Prevailing Wage Determination established by the Pennsylvania Department of Labor and Industry or the Davis-Bacon Wage Determination established by the United States Department of Labor.

A MANDATORY pre-bid meeting will be held on July 31, 2017 at 10:00 a.m. at Borough Hall, 100 South Second Street, Chambersburg, Pennsylvania.

Bids shall be submitted only under the "Bid" tab within PennBid. While Bidders may make comments to clarify their bid, Bidders cannot change, modify, delete, alter, amend or make additions to the wording to any of the Bidding Documents, including but not limited to the Agreement. Unauthorized conditions, exceptions, limitations, or provisions attached to a Bid may be cause for rejection of the Bid. Any questions regarding the Bidding Documents shall be submitted via PennBid's "Questions" tab and the Bidding Documents may only be modified through addenda issued by the Borough prior to the Bid opening date.

The Town Council of the Borough of Chambersburg reserves the rights to reject any or all Bids; to waive any defects, errors, omissions, irregularities or informalities in a Bid or the Bid procedure; and to accept any Bid which it may deem to be for or in the best interest of the Borough of Chambersburg.

Bids will be received via the PennBid Program (www.PennBid.net) until 2:00p.m. Eastern Standard Time, on August 14, 2017.

The Town Council reserves the rights to formally accept a Bid and award a Contract by public announcement at a regular meeting of the Town Council.

The Borough of Chambersburg is an Equal Opportunity Employer. There shall be a Minority Business Enterprises (MBE) goal of 5% and a Women's Business Enterprises (WBE) goal of 3%. The proposed Contract is also subject to the Section 3 requirements with a goal of 5% of the total contract amount.
