- 3. Signed Maintenance Agreement or Easement Agreement (Structural BMP Credit and Easement Credit)
- 4. Agreement recording fee (Structural BMP Credit and Easement Credit)
- 5. Escrow deposit (Structural BMP Credit)
- The Borough may require design documentation, as-built or construction drawings, and proof that the facility is in proper working order (existing facilities only) from a Pennsylvania licensed engineer, surveyor or design professional.


What is stormwater and why is 'management' so important?

- Stormwater is rainfall, snow melt, drainage water, wash water...
 - Runoff, ground water recharge, infiltration, water quality
- Stormwater can cause flooding, erosion, structural problems for infrastructure, and stream degradation

A little history:

- Chambersburg was settled in 1730
- In the early 19th century (1800's) some areas of Chambersburg appeared rough and unpleasant with some streets being impassable because of the deep mud

'The first step toward correction of these conditions was taken in 1813 with the awarding of a contract for street repairs. But the fundamental problem of surface drainage was not approached until 1823, when a storm sewer was constructed in Burkhart Avenue between Main Street and the Conococheague Creek' Chambersburg, It's Record and It's Prospect)



- All stormwater in the Borough goes to either the Conococheague Creek or the Falling Spring Creek
- The older parts of the Borough has minimal to no stormwater management; what does this mean?
 - Curb and gutter







- Newer parts of the Borough have stormwater best management practices
 - Norland Avenue, Chambers 5 Business Park
- What are best management practices?
