Be it ordained by the Mayor and Town Council of the Borough of Chambersburg, as follows:

SECTION NO. 13 The following shall be DELETED FROM Article III, Parking Regulations, Section 286.29, Parking Prohibited in Specific Locations Certain Days and Hours:

Highway - McKinley St

Side - North

Between - Fourth St and Stanley Ct and a point 360 feet East of Stanley Ct and Sixth St

Days - Every Day except Sat, Sun and legal holidays

Hours - 1:00 am to 7:30 am

Highway - Sixth St (south)

Side - West

Between - Tolbert Ave and East McKinley St

Days - Mon through Fri

Hours - 7::00 am to 4:00 pm

**SECTION NO. 16.** In all other respects, Chapter 286 of the Code of the Borough of Chambersburg shall be and remain in full force and effect

<u>SECTION NO. 17.</u> Saving Clause. Nothing in this Ordinance shall be constructed to affect any suit or proceedings pending in any court, or any rights acquired, or liability incurred or any cause or causes of action acquired or existing, under any ordinance hereby revised or otherwise affected by this Ordinance, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

**SECTION NO. 18.** Severability: The provisions of this Ordinance are severable and if any of its sections, clauses or sentences shall be held illegal, invalid or unconstitutional, such provision shall not affect or impair any remaining sections, clauses or sentences of the same.

SECTION NO. 19. Effective Date: This Ordinance shall take effect on March 23, 2020.
