SEALED – MISCELLANEOUS SCRAP ALUMINUM BID FORM

The undersigned bidder for the sale of miscellaneous scrap ALUMINUM located at 80 South Franklin Street shall submit an offer(s) following either of the following options:

Option 1: Bidder shall pick up said scrap by bidders' truck and by bidders' own labor, except that Borough will assist in loading by fork lift onto bidders' truck. Pick up to be between 8:00 A.M. to 2:00 P.M., Monday through Friday. Scheduling to be arranged with the Warehouse Supervisor by calling 717-251-2025.

Bidders' truck shall be empty-weighed at the Green Waste Facility, 491 W. Commerce St, Chambersburg in the presence of a Borough representative. Loaded truck shall be weighed at same scale in the presence of a Borough representative. If Borough scrap containers are on truck, the weight labeled on their sides shall be deducted from the loaded weight. Containers shall not be taken from Borough yard except as mentioned above.

All expenses incurred in weighing and transporting is to be paid by bidder.

Option 2: Borough shall deliver the said scrap to a location provided by bidder. Delivery will be done Monday through Friday between 8:00 A.M. to 2:00 P.M. as scheduled between the parties.

Sealed Bid must be received by May 15, 2019 at 2:45pm.

Successful bidder(s) will be required to make a deposit equal to **5,000 lbs.** of scrap at bid price prior to removing any aluminum from yard. Deposit must be by certified check, cashier's check, or cash.

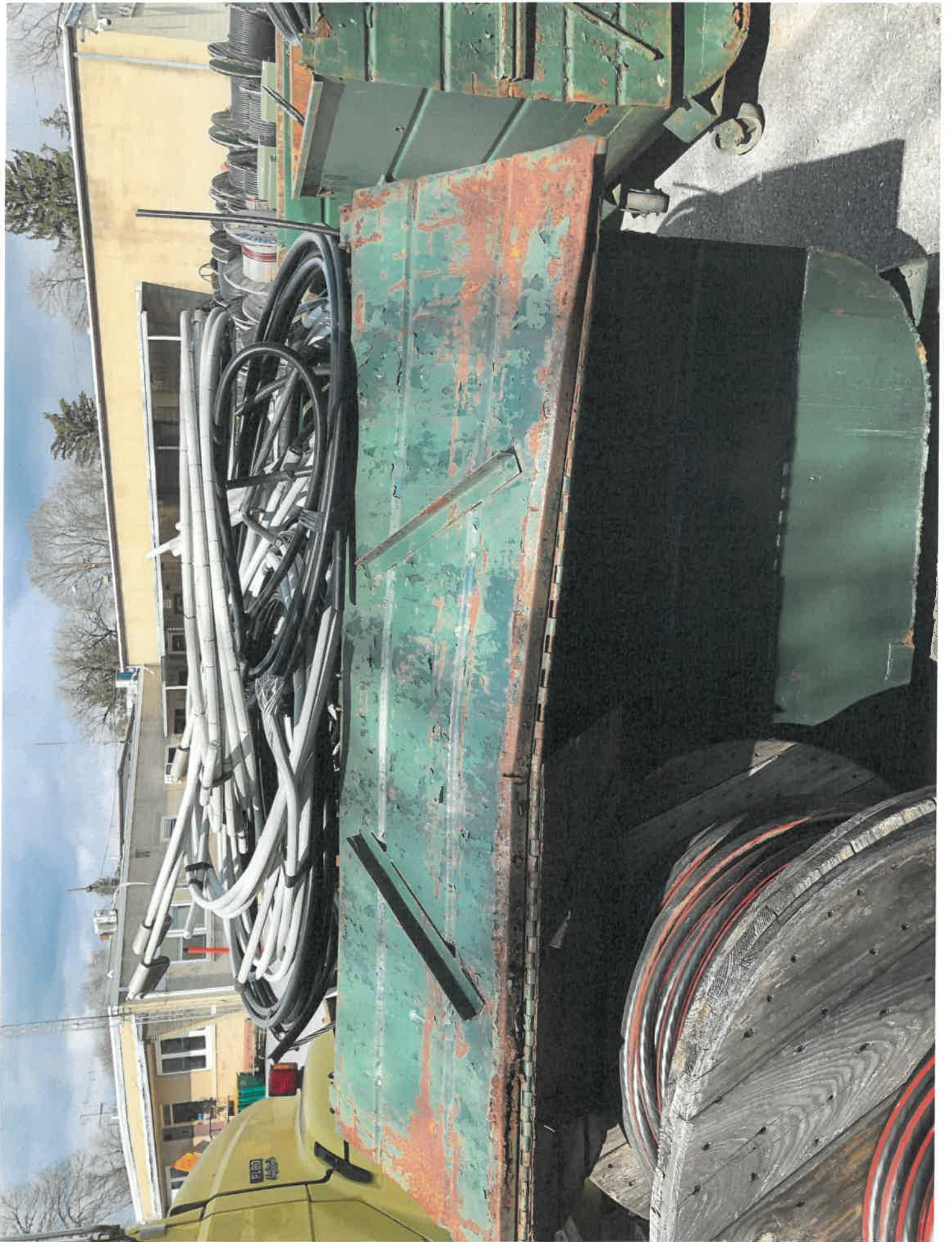
