Notice is hereby given that the Town Council of the Borough of Chambersburg, Franklin County, Pennsylvania, intends to consider for adoption and to vote upon an enactment of the Ordinance summarized below, at the regularly scheduled Chambersburg Town Council Meeting on September 13, 2021 7 p.m. at the Borough Office, 100 South 2nd Street Chambersburg, Pennsylvania 17201.

The title of the proposed Ordinance is "AN ORDINANCE OF THE BOROUGH OF CHAMBERSBURG, FRANKLIN COUNTY, PENNSYLVANIA, AMENDING CHAPTER 261 TO AMEND REGULATIONS REGARDING TATTOO AND BODY PIERCING ESTABLISHMENT HEALTH AND SANITATION REQUIREMENTS"

If enacted, the Ordinance will adopt updated rules and regulations regarding the health and sanitation requirements of Tattoo and Body Piercing Establishments in the Borough.

The contents of the Ordinance are summarized as follows:

SECTION 1: Amends Chapter 261, Section 261-9, Subsection A(5) to modify the requirements for waste containers in Tattoo and/or Body Piercing Establishments.

SECTION 2: Amends Chapter 261, Section 261-9, Subsection C(12) to require an Operator who has completed an approved course on the control and prevention of blood-borne disease be present during all hours of a Tattoo and/or Body Piercing Establishment's operation.

SECTION 3: Amends Chapter 261, Section 261-9, Subsection C(13) to require an Operator who has completed an approved course on the administration of adult CPR be present during all hours of a Tattoo and/or Body Piercing Establishment's operation.

AN ORDINANCE OF THE BOROUGH OF CHAMBERSBURG, FRANKLIN COUNTY, PENNSYLVANIA, AMENDING CHAPTER 261 TO AMEND REGULATIONS REGARDING TATTOO AND BODY PIERCING ESTABLISHMENT HEALTH AND SANITATION REQUIREMENTS

WHEREAS, the Borough Code, 8 Pa. C.S. § 101, et seq., at Section 1202(20), authorizes the Borough of Chambersburg (the "Borough") to provide for the licensing and regulation of business unless prohibited by law, 8 Pa. C.S. § 1202(20)(ii); and

WHEREAS, Section 1202(5) of the Borough Code, 8 Pa. C.S. § 1202(5), authorizes the Borough to make regulations as may be necessary for the health, morals, general welfare, cleanliness, convenience, comfort, and safety of the Borough; and

WHEREAS, Section 1203 of the Borough Code, 8 Pa. C.S. § 1203, authorizes the Borough to make and adopt all ordinances, bylaws, rules and regulations not inconsistent with or restrained by the Constitution of Pennsylvania and laws of the Commonwealth as may be expedient or necessary for the proper management, care and control of the borough and the maintenance of safety and welfare of the borough and its trade and commerce; and

WHEREAS, on September 14, 2020, the Town Council for the Borough ("Town Council") enacted Ordinance 2020-06 establishing the Borough of Chambersburg Tattoo and Body Piercing Establishments Ordinance, codified at Chapter 261 of the Code of the Borough of Chambersburg (the "Code"); and

WHEREAS, the Board of Health of the Borough has reviewed Chapter 261 of the Code and recommended to Town Council that certain amendments be made thereto; and

WHEREAS, the Mayor and Town Council of the Borough of Chambersburg have determined it to be in the best interests of the residents of the Borough of Chambersburg to amend certain provisions of Chapter 261 of the Code in the manner set forth below.

NOW THEREFORE, BE IT ENACTED AND ORDAINED, by the Mayor and town Council of the Borough of Chambersburg, Franklin County, Pennsylvania, and it is enacted and ordained as follows:

SECTION 1. Chapter 261, Section 261-9 of the Code of the Borough of Chambersburg, entitled "Health and sanitation requirements" subsection A(5) is hereby amended to read as follows:

(5) An easily cleanable waste container must be provided in the tattooing and/or body piercing area for waste materials.

SECTION 2. Chapter 261, Section 261-9 of the Code of the Borough of Chambersburg, entitled "Health and sanitation requirements" subsection C(12) is hereby amended to read as follows:

(12) During all hours of operation, a staff member or Operator who has completed an approved course on the control and prevention of blood-borne disease must be present.

SECTION 3. Chapter 261, Section 261-9 of the Code of the Borough of Chambersburg, entitled "Health and sanitation requirements" subsection C(13) is hereby amended to read as follows:

(13) During all hours of operation, a staff member or Operator who has completed an approved course on the administration of adult cardiopulmonary resuscitation (CPR) and who has a valid certification therefor must be present.

SECTION 4. Repealer. All provisions of the previous ordinances of the Borough of Chambersburg, which are contrary to this ordinance, are expressly repealed.

SECTION 5. Savings Clause. In all other respects, the ordinances of the Borough of Chambersburg shall remain as previously enacted and ordained.

SECTION 6. Severability. The provisions of this Ordinance are severable, and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provision shall not affect or impair any remaining sections, clauses, or sentences of the same.

SECTION 7. Effective Date. This Ordinance shall be become effective upon adoption.
